Topic 1. Evolution of social protection systems in the EU:

Main stages in the evolution of social protection systems in Europe. The first stage (before 1914) forming social security systems. The second stage (1914-1945) developing compulsory social insurance. The third stage (1945-1980) approving universality of social security within the welfare state. The fourth stage (1980-present) facing the crisis of social insurance systems and welfare state concept.

Topic 2. Basic models of social protection: Bismarck Model, Beveridge Model:

Criteria for selecting the models of social security. Insurance model (Bismarck Model): history of forming, principles of organising and functioning. States with traditional features of Bismarck Model. Universal model (Beveridge Model): history of forming, principles of organising and functioning. States with traditional features of Bismarck Model. Combination of features of the universal and insurance models in modern systems of social protection in the EU member states.

Topic 3. Features of social security law in modern Western, Eastern and Northern Europe:

Models of social law: Anglo-American (liberal), Franco-German (corporatist), Scandinavian (social democratic). Features of legal regulation of certain types of social security: pensions, social benefits for children, payments on disability, unemployment, etc.

Topic 4. Development trends of social law in the EU member states:

Increasing role of international legal standards in the social sphere.
