

## 8. INFORMATION ON THE NATIONAL EDUCATIONAL SYSTEM/ ИНФОРМАЦИЯ О НАЦИОНАЛЬНОЙ СИСТЕМЕ ВЫСШЕГО ОБРАЗОВАНИЯ

Following levels of high professional education exist in Russian Federation:

High professional education, confirmed by giving qualification (degree) of bachelor to the person successfully passed the final attestation - undergraduate studies.

High professional education, confirmed by giving qualification (degree) of specialist or master to the person successfully passed the final attestation – preparation of specialists and masters.

Normative periods of time for educational programs with full-time tuition of high professional education are:

For bachelor degree – 4 years

For specialist degree – not less than 5 years

For master degree – 2 years

\* The list of qualifications (specialties), which could have another standard of the period of time for taking main programs of high education (bachelor programs, programs of the specialist development or master degree program) is established by Government of Russian Federation.

Individuals, who took their diplomas of the state standard about according level of high professional education, confirmed by the given qualification (degree) “bachelor”, have the opportunity to be selected from among other candidates and continue their education taking the master degree program.
